<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.							
<b>What?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. What we do	
How does Boston Private Wealth LLC protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.  We also maintain other physical, electronic and procedural safeguards to protect this information and we limit access to information to those employees for whom access is appropriate.
How does Boston Private Wealth LLC collect my personal information? Why can't I limit all sharing? What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account – unless you tell us otherwise.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. <ul style="list-style-type: none"> <li><input type="checkbox"/> <i>Our affiliates include our holding company, Boston Private Financial Holdings, Inc., and our affiliate Boston Private Bank &amp; Trust Company.</i></li> </ul>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. <ul style="list-style-type: none"> <li><input type="checkbox"/> <i>Boston Private Wealth LLC does not share with nonaffiliates so they can market to you.</i></li> </ul>
Joint Marketing	A formal agreement between nonaffiliated financial companies to jointly market financial products or services to you. <ul style="list-style-type: none"> <li><input type="checkbox"/> <i>Boston Private Wealth LLC does not jointly market.</i></li> </ul>
Other Important Information	
<p><b>For California residents:</b> In accordance with California law, we will not share information we collect about you with companies outside of our corporate family, except as permitted by law, including, for example, with your consent or to service your account. We will limit sharing among our companies to the extent required by California law.
